Minutes from December 9, 2019

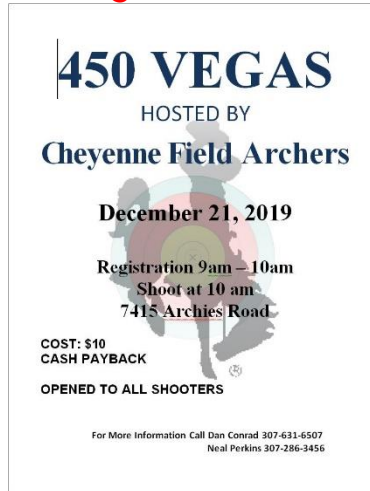
Attendance: Kelly Thornberry, Rob Sherman, Kayla Ketterling, Lora Ketterling, Kent Ketterling, Brian Skiba, Mike Lancaster, Greg Wooden, Dan Conrad, Chris Moody, Jim Mallon, Bob Graham, Cleata Zelenka, Neal Perkins, Amy Porter, Mat Rusk, Gary Cox

- Meeting called to order at 7:02 pm by President Bob Graham.
- We have 244 current members. **Memberships expire on December 31st!**
- Minutes from the November 11th board meeting were summarized by Gary. Motion made to accept minutes by Neal; Dana seconded. None opposed.
- Cleata handed out copies of the latest financial reports. There is now little over \$8000 in the checking account; savings money has been recently transferred to it. Taxes and utilities have been paid and Trad shoot profits about to be added. Dan had a question about gift cards—bought for what and given where. Dan made a motion to accept Cleata's treasurer report; Chris seconded.
- **Old Business**
- Neal thanked everyone who helped on the successful Trad. Shoot. There were 25 shooters with 50% payback. The profit was \$156. Everyone enjoyed the fun shoots with Guadalajara gift card going to Morgan White Danielle Stafford & Al Tharp won \$10 ones. The Access Yes shoot will be Tue/Thu of current week. There has been a lot of advertising for it. Neal wants to offer a \$100 gift card, from Trad. shoot profit, to auction if 30-40 shooters attend the Access Yes shoot.
- Neal thanked the bathroom crew for the spotless work. The holes have been patched, wall painted and new dispensers installed.
- Mark Moore won the \$25 gift card from ticket sales at the leagues.
- A big thank you goes out to Jim Frauendienst for a couple snow removals during recent storm and donated Christmas trees.
- Neal had Rocky Mountain Restorations looked at the range floor. They estimated it would cost about \$2 per sq. foot to remove the paint or roughly \$9600. They demonstrated the stripping material and scrapping blade. Neal recommends the club doing it for about \$2000 in materials. Dan suggested we do half spans of 10 yds. at a time until we have 40 yds of flooring done. Neal will get an estimate for the chemicals and tools needed. After a season decide what next to do on floor.
- Coldwell Banker (Kim & Larry Sutherland) and #1 Properties (John Watkins) have become Triple Crown/BHW shoot sponsors and will receive free gold memberships, thanks to Neal and Amy.
- Bob and Cleata investigated the insurance question with respect to the club and the Scholarship Foundation and found it was organized correctly. The Foundation will pay around \$200 for their event insurance. Neal moved that we table any more discussion about this; Dan seconded.
- **New Business:** Chris, Neal, Dan and Jim "volunteered" to assist Kelly with Triple Crown. committee. Dan suggested limiting arrow size to .246" in Bowhunter Class. Dan will research and committee decide. This will only be a rules change.
- Cleata asked whether the subscription to Bowhunter magazine should be renewed. The consensus was no. Also, she recently contacted the person who did the taxes (Kevin Christenson) and found out that no line-item audit was done. Cleata also said six new 6 ft. folding tables were purchased. The group recommended gradually replacing our tables with new, lighter ones.
- Cleata asked about preparations for the annual meeting. Chris, Dan and others suggested a milk can dinner for an expected 30-40 people. Chris and Dan will provide the milk can cookers. Receipts for supplies are to be turned in to Cleata. Those with last names starting with A thru L should bring side dishes and those with M thru Z desserts.

- Lora asked that an industrial-type first aid kit be purchased and wall mounted outside the board room in case someone needs minor first aid. There was no objection to this.
- **See the proposed Bylaw changes in the Articles, Recognition of Duties, Financial Considerations, and Audit And Inventory on Page 3. The proposed Bylaws are also available on the club's website and Facebook page. This will be voted on at the annual meeting.**
- Motion to adjourn at 8:06 PM by Dan, seconded by Mat.

Article IV

RECOGNITION OF DUTIES

For recognition of their duties, all Board members and officers shall receive a Cheyenne Field Archers shirt. The four officers and 1 Board member shall also have their NFAA paid by the Cheyenne Field Archers **if needed**. There must be five (5) NFAA members to maintain NFAA accreditation (**No NFAA memberships will be paid by the Club for members other than the officers and 1 board member**).

Article VI

FINANCIAL CONSIDERATIONS

The membership shall vote on the annual budget during the annual meeting. All budget items may be paid without the approval of the members or the Board of Directors as to each individual item. All checks will be signed by either the President, Vice President, the Treasurer or Secretary. Only one signature will be required. There shall be ~~six~~ **five** separate bank accounts: checking, CD 1 & CD 2 funds, ~~Scholarship Fund~~, Savings II and building fund. **There will be no future movement of funds from Cheyenne Field Archers, Inc. without being presented and voted upon by the general membership. This includes changing banks, adding new accounts or closing accounts, etc.**

Article VIII

AUDIT AND INVENTORY

There shall be a **mandatory yearly transactional audit performed with a report either by an accountant or by a club committee of no less than 3 club members in good standing in December of each year prior to Annual Meeting and at any point that the Treasurer steps down.**and An inventory audit may be conducted in order to determine the financial status of the Club, if requested by any member in good standing.

Article XVIII

LIABILITY INSURANCE CERTIFICATES


All Organizations not affiliated with Cheyenne Field Archers, Inc. wanting to use the building for non-CFA affiliated events, must submit a request for use of facility and receive approval by Cheyenne Field Archers, Inc. board prior to use. Five (5) days prior to use the organization must sign a release disclaimer and present a Certificate of Liability Insurance reflecting Cheyenne Field Archers, Inc. as additional insured with the amount of \$1,000,000 \$2,000,000 aggregate coverage.

Memberships Expire at Midnight Dec. 31st!

Memberships expire on December 31st and access will be denied (your card de-activated) on January 31st, 2020, if not renewed.
