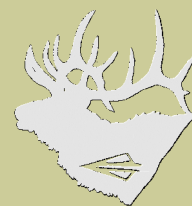

Cheyenne Field Archers Annual Board Meeting
Meeting Minutes
January 5th, 2013

Opening:

The annual meeting of the Cheyenne Field Archers was called to order at 5:43 pm on January 5th, 2013 by Michael Hoover, Vice President at the Cheyenne Field Archers Range.

Present:

Board members present: Mike Hoover, Monica & Jim Mallon, Mike Lancaster, Jeremy Cooke, Chad Whaley & Mary Tharp. Alternate board members Al Tharp and Robert Day were present.

A. Approval of Minutes & Treasurer's Report

The December treasurer's report was presented. Mike Hoover asked if anyone had any changes. . Then the proposed budget for 2013 was presented. Mike asked if there were any questions. He questioned the different target amounts. A Motion was made by Jeremy Cooke to accept the treasurer's report and the proposed budget. Chad Whaley seconded it. There was a unanimous vote on the budget, the budget passed.

B. Old Business.

Tents-Mike Hoover picked up one of the tents, the other was being worked on. Mike said he would check to see if that tent was ready.

Christmas Party-Mary Tharp reported that the Christmas party was held .

- c) **Triple Crown**- Mary reported that this board was working on the Triple Crown to help the new board out when they took over. Because past awards which were vests or hoodies depended on sizes of the winners and then they had to be stitched and last year we were behind and actually passed most of them out at BHW, the rest had to be mailed which cost the club \$12.00 each. So the clothing cost the club anywhere from \$82.00 to 95.00 depending on if we could find the clothing at a good price that was in the size ranges that we needed. So Jeremy Cooke researched what buckles would cost the club, which we could have on hand and present at the time of the final leg of the Triple Crown. He had previously checked with Wyoming Trophy and Engraving and then Giss Silver Smith Company who does our BHW belt buckles and they could give us a great discount for ordering these. There were two designs that was recommended and the members voted to accept the 2nd design at \$93.00 each. The winner has to have shot in all three legs of the Triple Crown. Discussion on whether we should have at least 4 shooters for each class to award a buckle. The members felt to do that would discourage shooters if there weren't at least 4 shooters, especially in the women's classes. The decision was to award a buckle whether or not there are 4 + shooters in a class. Young adult and below will receive a trophy.(26 out of 30 votes)
- d) **WSAA**- The club has no representative for WSAA.
- e) **Curt Gowdy-work party**. Mike Hoover reported that he has been discussing the range with Darren Westby and they are going to set up a meeting to discuss continued work at the Curt Gowdy range. All of the materials, the concrete slabs and target butts are up there, they need to be repositioned, tied down and the stakes set to finish the range. This project has been going on for 3 years. It's a shame to have that amount of work done and left in the unsafe state that it is in. Mike asked that the club members contribute a months worth of manpower to go up and finish the range so it can be safely used. The members present agreed to contribute a months worth of work and Mike will let the club know when that meeting is being held so that members can attend if they wish to.
- f) **State field in June**-Mike Hoover asked if the club wanted to vote to turn this over to another club. Neal Perkins made a motion to turn it over to another club within the State. Al Tharp seconded it. Vote was taken and the motion passed.
- g) **Old butts**-December meeting amotion was made by Jeremy Cooke that the club have a chance card game to raffle off the old targets, one at the annual meeting, and one at each of the Triple Crown shoots and one at the access Yes shoots. The motion passed so we will be holding that game after the meeting. Note: After the meeting, all the Cards were sold, they put the 2nd half of the card in the bucket and drew the winning number. Jim Mallon won the butt.
- h) **By-Law change** spelling out what a family membership is and what the limitations are. There was discussion about the age proposed in the new wording. Past practice has been, once the child of a member turned 18, they Were required to get their own membership. In addition, there are conflicts with the by-laws concerning the age.

Article XIII-Single Youth membership is anyone under the age of 18 and Article XIV – Voting Requirements, Any member in good standing who has attained the age of 18 years shall have the right to vote at all Club elections and functions.

It was felt by some members present that if they are afforded the right to vote on issues then anyone over 18 should have their own paid membership. Mark Rinker made a motion that **family membership is health of household, their spouse and children 17 years of age and under**. The motion was seconded by Brian Halverson. The motion was passed.

- i) **Club Logo**-the new logo contest had only one submitted. The vote was unanimous to accept the new logo.
- j) **Archer of the Year**-Bob Day opened the discussion with what the Archer of the Year represented, namely someone who not only promoted Archery within the club, but in the community. He nominated Mary Tharp as Archer of the Year based on her work within the club, in Girl Scouts, Boy Scouts, Super Day, the Parks and Recreation Outdoor Adventure Program. Neal Perkins also submitted that Mary attended the National Archery in the Schools Program to be able to teach archery to the youth. The members voted to name Mary Tharp Archer of the Year.
- k) **Donations of Targets** – Mike Hoover said he would like to address comments that the club voted to take 25% of the donations made during the Tuesday and Thursday night shoots to be put back into targets. These shoots are for fun and if we were to take 25% of the proceeds, some years, we couldn't afford targets. He said that it is his opinion that the board members are voted in to represent the best interests of the club and we should allow them to do their job. We buy targets once a year, because it is cheaper to buy in bulk and it just makes more sense to do it that way. Neal stated that there is a misconception that only the person running the shoots can determine if a target is substandard, he said anyone can bring it up if they think a target is substandard and it will be changed out. Neal Perkins made a motion that all money brought into the club, will be decided by the board on how it is spent, eliminating the previous 25% toward Tuesday and Thursday targets. Al Tharp seconded the motion. The motion was passed.
- l) **Facebook page**-Mike Hoover announced that he is building a facebook page. If anyone is experienced with making one, to let him know and they could work together and build one for the club.

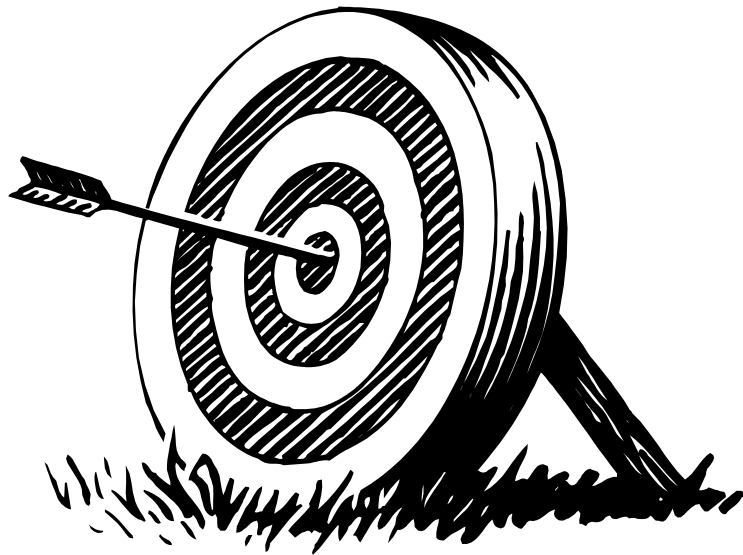
