CFA Annual Membership Meeting Minutes  
January 7, 2017

The CFA annual membership meeting was called to order at 5:50 pm by President, Dan Conrad. Approximately 36 members were in attendance.

2017 Proposed Budget – The 2017 Proposed Budget was reviewed line by line with limited discussion. Except for additions as mentioned later in the meeting minutes, Butch Rupert made the motion to accept the 2017 Proposed Budget as final; motion was seconded by Myron Reed; none opposed, motion passed.

## CFA Annual Membership Meeting Minutes Continued

### Mary Tharp

- Mary Tharp made a motion that the Bylaws be updated to include an annual mandatory audit; Laurie Schinzel seconded the motion; none opposed, motion passed.
- Mary Tharp made a motion that the CFA Club contribute \$1,000 to the Scholarship Fund. The contribution would be added to the 2017 Budget but would need to be voted on each year; Lora Ketterling seconded the motion; none opposed, motion passed.

### Michael Bean
