Meeting was called to order at 7:00pm by Board Vice President, Greg Wooden.

Minutes from the February meeting were reviewed and discussed. Motion was made by Dan Conrad to accept the minutes, second by Jim Mallon.

### **OLD BUSINESS:**

Triple Crown – Buckles were ordered and are currently in the mail. Should be here early the week of the third leg.

Wyoming State Shoot – 20 shooters. There were also multiple satellite locations happening at the same time.

Latch Key Kids program – Greg gave them a range of dates and we are waiting to hear back when they would like to come.

RMAA – Dan Conrad is finalizing details and will follow up with their board.

Inventory of 3D targets and cores – Wednesday, March 31<sup>st</sup> at 5:30. The club will order pizza for all volunteers. Old cores will be stacked up and given away. New cores need to be ordered by Mid May to receive by Bowhunters weekend.

Vegas Shoot – Kelly received the information for a virtual event. The event has to be held between March 12<sup>th</sup> & April 12<sup>th</sup>. Shooters can sign up via the NFAA website. Cost would be \$75 adults; \$50 kids and they are offering flight prizes. The club would be allowed to determine the format and which weekends to hold the event. Must shoot 90 arrows (3 rounds of 30 arrows). The board voted not to hold the virtual event due to time limits and availability of volunteers.

Volunteers are needed for the Triple Crown in March. Set up starts Friday the 19<sup>th</sup> at 3:00pm. Contact Greg Wooden for information. We will also raffle a couple of the big target butts.

#### **NEW BUSINESS:**

We were also invited to participate in Super Day. The venue is a little different this year and the space is much smaller so we may not be able to have the kids shoot archery. It would be just a vendor booth to promote the archery club. We will talk to the lady running the event and get more details before deciding whether to participate.

Lora Kettlerling, President of the CFA Scholarship Foundation approached the board about holding their annual fundraising dinner and auction on June 5<sup>th</sup> at the club. She also followed up on the certificates for membership that were given by the club last year. Would those be honored by the club since they were unable to hold the fundraiser last year? Both items were approved unanimously by the board.

Access YES shoot – We will hold Access Yes shoots on Tuesday, April 6<sup>th</sup> and Thursday, April 8<sup>th</sup> in the place of leagues those two nights. We will have door prizes and raffle prizes. The only cost will be to participate in the games offered.

We received word that the State was offering grants for work done in outdoor recreation areas in Wyoming. It was discussed to apply to replace targets in the warm up area at Curt Gowdy and also some on the range that are falling apart. Greg has contacted that state and is waiting to hear back. We will be doing a walk through to inventory targets and determine needs. The cost to replace the targets is \$750.
