Board Meeting

The regular board meeting of the Cheyenne Field Archers was called to order at 7:00 pm on October 4th, 2010 at the Cheyenne Field Archers Office.

Bob Day, Mary Jo Day, Matt Rusk, Bob Graham, Adam Lewis, Al Tharp, Mary Tharp, Jim Frauendienst, Mike Lancaster, Mike Hoover, and Neal Perkins were present.

New Business-to allow speaker to present and then leave without having to set in for the whole meeting.

Archery Range-Curt Gowdy State Park-Paul Gritten from the Wyoming State Parks and Historic Sites and Trails came to present changes to the current Archery Range out at Curt Gowdy State Park. He explained that the stairs that were build in the 1990(s) are rotting, that because of no back slope there is a lot of water erosion on the trails and some of the trails exceed a comfortable 8 % grade. The State Parks proposes that Cheyenne Field Archers join together with the State and redo the

range, keeping the existing number of target butts, reworking the trails not to exceed the 8% grade and creating a backslope to prevent water erosion. The project is expected to be started and completed next Spring. The state will have a trail contractor do the design and if the club wants to have a representative or two there, that would be great. They also propose to have an information kiosk (an open sided, covered structure, imparting information) where the club could post safety rules, contributor(s) information, club information, etc. The range will still have 2 – 14 target courses to retain the NFAA sanction. The state of Wyoming will put out the RFP for the club to buy the target butts. The State will also work it out with BOPU and the School District for access into land to make the 8% grade work out. There will only be 1/10th of a mile added to the course. Neal Perkins said there is some money in the Game and Fish Department's program to get the youth outdoors, that he will check into to see if they will also help with this project.

The club would also have to pay \$100.00 to offset some of the costs. The Board declined to host this tournament.

Other Business

It was also reported that Arrow Dynamics' leagues are starting up again the $18^{\rm th}$ of November.


